*Happy Holidays* to all VFW Auxiliary members of Washington State! The best gift that you can give to our veterans is a healthy and thriving membership!!! Here are the results of the November membership challenge. Out of 62 auxiliaries 12 were 95% plus by 11/30/23 and 13 auxiliaries were 100% or more. Give your auxiliary a big standing ovation! The 95% plus auxiliaries were: 921, 2289, 9079, 10018, 1694, 3057, 7824, 3617, 51, 1435, 9430 and 1045. The 100% or more auxiliaries were: 2329, 2669, 4992, 1948, 8956, 11402, 4278, 1263, 2995, 5056, 9301, 9474, 3482! Congratulations! The winner of the November 11<sup>th</sup> challenge was auxiliary 11402 (Tumwater-Lacy Auxiliary)11402 and won \$100!
